North Carolina Offers Business Tax Credit for Unemployment Insurance Payments. An employer is allowed a tax credit equal to the amount of Unemployment Insurance Fund contributions payable on the report filed by the employer on or before April 30, 2020. If an employer remitted the contributions payable with the report due on or before April 30, 2020, the credit will be applied to the contributions payable on the report due on or before July 31, 2020.

You are required to pay taxes if you are: A general business employer with gross payroll of at least \$1,500 in any calendar quarter or with at least one worker in 20 different weeks during a calendar year. An employer who acquires all or any portion of a liable business in North Carolina. An employer who voluntarily elects to become liable regardless of not meeting the required criteria.
