### **International Convention on Maritime Liens and Mortgages ...**

The vessel must be surveyed and measured to obtain details of size, and other descriptive particulars necessary for the registration of British Ships under the Merchant Shipping Act. This is carried out by a Surveyor of one of the approved Classification Societies (see section 11.1 (b)), or a Surveyor appointed or authorized by the Registry.
